Project Description

The Generating, Accessing and Using Information related to the 3 Rio Conventions project is in line with the GEF-5 CCCD Programme Frameworks two (2) and four (4), which call for countries to generate, access and use information and knowledge and to strengthen capacities to implement and manage global convention guidelines. It is also aligned with the first objective of GEF6 that is to integrate global environmental needs into management information systems (MIS). It is a direct response to national priorities identified through the National Capacity Self-Assessment (NCSA) conducted in 2005-2006 and that is part of the institutional strengthening underway at MOE and MAFF. Through a learning-by-doing process, this project will harmonize existing environmental information systems, integrating internationally accepted measurement standards and methodologies, as well as develop a more consistent reporting on the global environment. Under the first outcome, the project will support the strengthening of Cambodia's capacity to better engage stakeholders and better coordinate the implementation of the Rio Conventions in the country. And under second outcome, project resources will be used to improve the use of environment-related information for the development of innovative tools supporting decision-making processes related to the implementation of the Rio Conventions. The project support will also include activities to develop the capacity in using this environment-related knowledge of national institutions involved in international negotiations at Conventions COPs, as well as using this knowledge to produce national report meeting conventions reports obligations.

The project's objective is to improve access to environmental information related to the Rio Conventions through the harmonization of existing environmental management information systems and improving coordination of the implementation of these existing systems will be translated into better access to information related to the implementation of the Rio Conventions in Cambodia.

The project is delineated into two main components:

Component 1: Improved access and generation of information related to the three Rio Conventions

Component 2: Improved use of information and knowledge related to the Rio Conventions

The three Rio conventions project will take into full consideration the need for a Communications and Partnership Specialist (CPS) in project workings. The CPS will guide the process of assessing communication strategies of knowledge and information mainstreaming related to the Rio conventions in all areas and at all levels.

The CPS will also lead the effort to building and sustaining strategic partnerships aiming at advancing UNFPA mandate issues and mobilizing resources for three Rio convention project. The CPS is responsible for the development and implementation of the country office resource mobilization and partnership strategy and plan. The key results of this consultancy will be creation and maintaining of strategic partnerships, revision and implementation of partnerships development strategy with a focus on all areas and at all levels.

The project will ensure that the concerns and experiences of stakeholder on biodiversity conservation, climate change, and land degradation are an integral dimension of the design, mainstreaming, implementation, monitoring, and evaluation of project resulting policies and programs, with the purpose of ultimately achieving communication strategy on information sharing.

Scope of Work

The CPS will be recruited based on an open and competitive process to complete a communication and partnership strategies for the three Rio conventions project. The CPS will be hired to conduct a communication and partnership assessment and analysis, develop both, the 3Rio communication and partnership strategies, which includes information mainstreaming and networking that outlines the way in which stakeholders can participate in the Clearing House Mechanism. The partnerships strategy includes standardized operational procedures to formalize partnerships on liberal information sharing.

The CPS will report to Project Coordinator and may participate in the meetings of the Project Board workshops as a resource person as necessary.

Duties and Responsibilities

The tasks and responsibilities of CPS will be the following, but not limited to:

- 1. Conduct baseline assessments and analysis at environmental information mainstreaming of three conventions in national levels and with a wide variety of stakeholders (government, non-government organisations, and web-users) to identify communication and partnership strategies, including mapping exercises;
- 2. Develop communication tools, awareness raising instruments and monitoring strategy to measure the impact of the communication campaign over time in decision-making processes at national and decentralised levels, including explanatory note content with operations, contracting, terms of reference, budgeting and reporting format;
- 3. Identify national dialogue platforms so as to enhance coordination and promote synergies among these platforms, including by identifying or, as appropriate, establishing a crosscutting (i.e. interagency, inter-departmental, inter-sectorial, inter-disciplinary) platform with clear and manageable terms of reference and formalizing it;
- 4. Develop partnership strategy in line with the Project Document and Inception Report, with the aim to strengthen environmental information delivery to and from decision makers;
- 5. Identify best practices and lessons learned directly linked to resource mobilization and partnership-building activities.
