II. Background

CAMPAS, short for 'Strengthening national biodiversity and forest carbon stock conservation through landscape-based collaborative management of Cambodia's protected area system as demonstrated in the Eastern Plains Landscape', is a project funded by GEF Trust Fund. As its title suggests, the project holds the interconnected aim to improve the sustainability of Cambodia's national system of protected areas, with the complementary objectives to mainstream biodiversity into production forests and promoting conservation of carbon stocks.

The project is delineated into two main components:

Component 1: Strengthened national vision and support for landscape-based protected area and forest management.

Component 2: Integrated landscape management to safeguard forests, biodiversity, and carbon stocks in the Eastern Plains Landscape.

The project design comprises two major outcomes, one at the national level and a supportive outcome at the demonstration site level. At the national level CAMPAS comprises three specific outputs, all oriented to strengthen unity and support for landscape—based protected area and forest management that explicitly addresses national system level issues through measures that that include establishing the enabling environment at national level, through communications and awareness, strengthening protected area governance involving interagency cooperation, and demonstrating sustainable financing options. At the demonstration

site level, the CAMPAS's four outputs will deliver a sub-regional planning approach for the Eastern Plains Landscape that integrates protected areas and biodiversity conservation into sustainable development – with specific focus on forested landscape connectivity. At this level it also focuses on integrating forest conservation with sub-regional economic development planning, trying to resolve issues presented by economic land concessions that often ignore and impact upon protected areas, and harnessing integration opportunities with other landscape-level initiatives like those of the Asian Development Bank Biodiversity Conservation Corridors and United Nations Environmental Program Adaptation Fund projects.

The total project budget is **4,718,182 USD for the period of 60 months**. The project will be executed by the **Ministry of Environment** and implemented by United Nations Environment (UN Environment) in close cooperation with other NGOs partners and stakeholders.

III. Scope of Work

Under the overall guidance and supervision of the National Project Director, the selected National Consultant will work closely with Project Coordinator, CAMPAS project partners and relevant institutions/stakeholders to complete the assignments. Tasks and responsibilities of consultant include but are not limited to:

Main Duties and Responsibilities

- Conduct a desk review, analysis and identify possible options for a synergistic and coherence conservation recommendations among PA system and biodiversity corridor areas in comply with a new reform of government Conservation;
- Provide a comprehensive policy analysis relevant to PA and biodiversity management with applicable recommendations for CAMPAS to consider, apply and pilot. Develop an effective coordination strategy among CAMPAS partners to achieve CAMPAS's deliverables and outcomes;
- Develop policy briefs, technical inputs, factsheets, case studies, reports, and other outreach materials to support CAMPAS priorities;
- Be able and willingness to travel as needed;
- Other tasks as requested by the Project Management Unit.
